My teaching responsibilities have included instruction from freshman level to graduate level. Specific courses include Introduction to Agricultural Economics, Advanced Farm Management, Mathematical Economics, Linear Programming and Quantitative Technique, Resource Economics, and Environmental Economics. I have counseled undergraduate students on curriculum and directed several Masters and Ph.D. theses. I have served on numerous graduate committees within the Department of Agricultural Economics as well as within other departments in the Division of Agriculture. Participated on internal curriculum evaluation committees and self-study teams.

My research includes applied analysis in farm management and resource economics. I have developed many research projects and served as a member of several interdisciplinary teams performing economic feasibility and analysis research for beef cattle, forages, cotton, soybeans, rice, and general farm management. I have developed and published several computer software packages designed to aid producers in record keeping, reporting, decision making, policy and government program analysis. I have participated on several regional research teams developing simulation models used in beef cattle research. I co-edited a book involving computer simulation modeling. I developed annual enterprise budgets for beef, forage, rice, cotton, and soybeans for distribution throughout the State. I co-developed and authored the computer software and methodology used in these budget preparations. I have secured funding and performed research for a US Army Corps of Engineers contract involving economic impact on agricultural producers of a declining alluvial aquifer in the Delta of Mississippi. I have authored and co-authored numerous publications and papers during the course of this research (refer to

publication list). Provided management oversight and directed office personnel, graduate students, and research associates. I have worked closely with scientists in many other disciplines and individual agricultural producers on various research projects across virtually every Experiment Station in the State and across every area of the State.

I had major research responsibilities for seven years in the economics of beef cattle production and forage management. For the past 15 years responsibilities have been in production and farm management economics of cotton, rice, soybeans, agricultural policy, resource economics.

Since 1995, I have coordinated the Departmental enterprise budget development process, which includes facilitating Departmental faculty in enterprise budget development and coordination of data input collection, budget preparation and publication, and final distribution to clientele. Also since 1995, I have coordinated the Division of Agriculture project with the State Tax Commission on Agricultural Use Value Assessment. That project includes the Department of Agricultural Economics, Mississippi Agricultural Statistics Service, the MSU Forestry Department and the Mississippi Extension Service as well as the State Tax Commission. Most recently, from 1996 to the present, I have coordinated the MAFES effort in precision farming and Advanced Spatial Technologies in Agriculture (ASTA). In 1998 the effort included eighteen projects and more than twenty scientists. In 2000 the effort includes more than 25 projects and 37 scientists.

I have served on numerous departmental and University committees including: departmental Graduate Examining; Teaching Evaluation; Computer Advisory Research Program and Policy; Research Evaluation; as Chairman, Experiment Station Cotton Economics RPM Work Group; and University Fringe Benefits. I served as Secretary of Regional Research Project S-156. I have chaired several AAEA and SAEA selected paper sessions and discussion panels at professional meetings.
